

Photographic Contest **DIGISCOPING IN DELTA**

REGULATION

Art. 1 Promoting subject

EBN Italia Association, jointly with DELTA 2000 and in the field of International Po Delta Birdwatching and Nature Tourism Fair 2010, announces the photographic contest "**Digiscoping in Delta**", amateur or professional Italian photographers can participate to, using the digiscoping technique (photography with digital reflex or compact camera connected to the telescope).

Art. 2 Contest's subjects and categories

The photographic contest is shared in three subjects:

a) **BIRDS of Po Delta**

In this category photos taken in nature of Po Delta Birds will be accepted

b) **MAMMALS of Po Delta and of the world**

In this category photos taken in nature of Po Delta and world mammals will be accepted

c) **SEQUENCE PLANS**

In this category photos mixed by dynamic sequence will be accepted.

Art. 3 Typology and quality of photographic images

3.1 Images, maximum 4 for each subject, are accepted if sent as digital files in JPG with 300 dpi in the largest side included among 3000 and 3500 pixels.

3.2 All photos must precisely reflect the object and the scene as it appeared to the photographer.

3.3 Each contestant can participate in one or more subjects, sharing his works, in the computer support, in folders countersigned by the subject which he intends to participate in. The works' title must be mentioned in the Participation Form.

3.4 Photos digitally altered beyond the standards of optimization will be disqualified. Allowed changes are the adjustments of color, contrast, brightness and neatness.

3.5 The Jury will give its preference, in case of parity, to images containing digital origin indications (=metadata).

3.6 Composed photos (combination of two or more photos), the addition, the duplication, the cancellation or the move of objects in the photo, or the use of digital artistic filters are not allowed.

3.7 Images representing animals in captivity, in the nest or in their reproductive site are not allowed.

Art. 4 Modalities of registration, requirements and condition for the participation and exclusions

4.1. Amateur or professional Italian photographers using the digiscoping technique (photography with digital reflex or compact camera connected to the telescope) can participate.

4.2. The participation to the contest is subordinated to the registration that must be effected compiling the card of participation, enclosed to this regulation and available at the www.podeltabirdfair.it and www.ebnitalia.it web site.

4.3. Each participant must send the Participation Form duly filled in all its parts, in capital letters and correctly signed where requested (not signed forms don't participate to the contest). The works' title must be indicated in the Participation Form.

4.4 The delivery of the Participation Form, together with the CD/DVD, can happen through the following modalities:

4.5. Supports with images presented to the contest will not be returned.

4.6. Involved people (and their relatives), at any title, in the organization of the Fair or of the Jury, can't participate.

Art. 5 Utilization of the photographic material and copyright

5.1 Rights and propriety of images still remain of owners of the same images; they grant, for free, to organizers and partnerships the utilization of photos sent to the contest, for the following uses: catalogue printing, release on websites in fields related to the contest, exhibition and projection during promotional demonstrations, the eventual settlement of exhibitions or all that needs the contest's promotion.

5.2 Quaderni di birdwatching – EBN Italia Magazine, DELTA 2000 and the sponsor companies of prizes of this photographic contest have the right to use for free images reached to the contest for eventual releases, communicating it to the author.

5.3 For each use of images the organizers will always cite the authors' name.

Art. 6 The Jury

6.1 The contest Jury is composed by 3 members.

6.2 The Jury will select and classify to its own unquestionable judgement worthy works and it reserves to not accept images whose realization is supposed to have caused some damage to portrayed species.

6.3 Jury's judgement is unquestionable and it will be based on the technical and naturalistic relevance of images.

Art. 7 Prizes

7.1 The first three classified works for each subject/category and the best photo will be awarded:

7.2 Prizes are:

- **Overall winner – Best Photo Prize:** Swarovski Optik Habicht 10 x 40 WGA Binocular worth of 995,00 Euro + year's subscription to "Rivista della Natura".
- **1st classified Birdlife of Po Delta category** – photographic and optics material worth of € 400.00 + year's subscription to "Rivista della Natura".
- **2nd classified Birdlife of Po Delta category** – week-end for 2 people in Po Delta Park worth of 200.00 Euro in b&b + year's subscription to "Rivista della Natura".
- **3rd classified Birdlife of Po Delta category** - photographic and optics material worth of 100.00 Euro + year's subscription to "Rivista della Natura".
- **1st classified Mammals of Po Delta and of the World category** - photographic and optics material worth of 400.00 Euro + year's subscription to "Rivista della Natura".
- **2nd classified Mammals of Po Delta and of the World category** - week-end for 2 people in Po Delta Park worth of 200.00 Euro in b&b + year's subscription to "Rivista della Natura".
- **3rd classified Mammals of Po Delta and of the World category** - photographic and optics material worth of 100.00 Euro + year's subscription to "Rivista della Natura".
- **1st classified Sequence Plans category** - photographic and optics material worth of 400.00 Euro + year's subscription to "Rivista della Natura".
- **2nd classified Sequence Plans category** - week-end for 2 people in Po Delta Park worth of 200.00 Euro in b&b + year's subscription to "Rivista della Natura".
- **3rd classified Sequence Plans category** - photographic and optics material worth of 100.00 Euro + year's subscription to "Rivista della Natura".

7.3 Prizes are not combined in single sections, but they can be combined in different sections.

7.4 Prizes must be personally withdrawn by the winner during the awarding or by writing delegate person. Differently, they will be sent home, by courier or post, at the expense of the recipient.

Art. 8 Disclaimer

The organization, even if it assures the maximum attention in manipulation of received data, disclaims any responsibility for eventual damages or loss, any cause they are generated from.

Art. 9 Contest's duration

Works can be sent starting from 05/02/2010 and they obligatorily must reach, in accordance with the modalities indicated in the art.4, to **EBN ITALIA** Via Allende 3, 27100 PAVIA **e-mail** at ebnitalia@ebnitalia.it by 15th April 2010.

Art. 10 Awarding

The ceremony of awarding will have place on Friday 30th April 2010 at 6.00 p.m. Bellini's Palace - Comacchio (Ferrara) with projection of works.

Only the authors of the winning works will be contacted by telephone or e-mail.

Results will be announced on www.podeltabirdfair.it. and www.ebnitalia.it sites.

Art. 11 Final dispositions

The participation to the Contest presupposes the knowledge of the present regulation and it presupposes, by the participant, the total acceptance of the present regulation.

Art. 12 L.D. informative 196/2003 on the Treatment of personal details - Privacy.
